

**CITY OF SUNRISE BEACH VILLAGE
ORDINANCE NUMBER 215**

AN ORDINANCE ESTABLISHING PROCEDURES FOR RENTAL OF THE McNAIR PARK MAIN PAVILION, SETTING FEES FOR RENTAL AND PROVIDING FOR COLLECTION OF SUCH FEES.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF SUNRISE BEACH VILLAGE, LLANO COUNTY, TEXAS:

WHEREAS, The City of Sunrise Beach Village is fortunate to have a park pavilion for use by the citizens of Sunrise Beach, and

WHEREAS, It is incumbent upon the Board of Commissioners to regulate the use of the McNair Pavilion to make it available to individuals and groups in our City, and

WHEREAS, It is appropriate for the Board of Commissioners to set fees for use of the Pavilion to help cover the cost of maintenance of the Pavilion facilities, and to establish penalty fees for any who fail to properly clean the facility after use and/or cause damage to occur to the Pavilion and surrounding park property owned by the City;



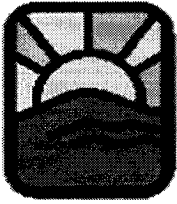
