NOTICE OF AN EMERGENCY CALLED MEETING OF THE CITY COUNCIL

Notice is hereby given that the City of Sunrise Beach Village will meet on April 30, 2020 at 2:30 p.m. at the Civic Center, 124 Sunrise Drive, Sunrise Beach Village, Texas for the purpose of the following; and,

Public notice is hereby given pursuant to the Texas Open Meetings Act, Chapter 552 of the Texas Government Code, of the following imminent threat to public health and safety or reasonably unforeseeable situation necessitating this emergency agenda:

Because of the potential for loss of life and property to the residents of the City resulting from the introduction, transmission, spread or imminent threat of the same of the Coronavirus disease 2019 (also known as COVID-19), an emergency, urgent public necessity and imminent threat to public health and safety exists that requires immediate action of the City Council. Pursuant to Texas Government Code Section 551.041 and 551.045, notice is hereby given of the City of Sunrise Beach Village.

The meeting will be held in compliance with the Order meaning that no more than ten (10) people (including City Council and City staff) will be allowed in the City Council Chambers. We ask that you follow the Order, maintaining at least six (6) feet distance from other people and minimize the surfaces you touch. It is strongly recommended that you stay home if you fall within the vulnerable population; are showing the symptoms described in the Order; or have had contact with a person who has been diagnosed with COVID-19 or who is showing symptoms of the illness. A Sunrise Beach Law Enforcement Officer will be present to allow the allotted number of people within the chamber to speak as "Citizen Comments;" however, unless the item is on the agenda only matters of fact may be discussed.
