Please click on the CORRECTED link below to report damages caused by the recent freezing weather. This will help residents and businesses within Llano County receive the help they need.

The February 2021 freeze was truly an historic event for Llano County. We declared a local disaster on February 15, 2021 but individual damage reporting is needed.

The Texas Division of Emergency Management (TDEM) has created a "Self-Reporting Survey" where residents can report damage directly into a form which assists Llano county more accurately track damage that will be very useful for our county's Disaster Summary Outline (DSO) and increasing the level of Federal Support for our community.

Due to the widespread nature of this incident residential damage could be just about anywhere within Llano county. PLEASE SHARE THIS LINK with other Llano county residents in order to more accurately report damage to TDEM and FEMA.
